Message from Rebecca Whillans, Chief Executive

Included in this newsletter is an update from Steven Bierema, director, Storage progress & we invite applications for the Associate Director role for 2025.

ALIL Associate Director Role

Ashburton Lyndhurst Irrigation Ltd (ALIL) seek Expressions of Interests for an Associate Director - giving the candidate an opportunity for personal and professional development, and an introduction to a governance role within ALIL.

This opportunity provides first-hand exposure to the role of the Board, its decision making and operations, as well as training and mentorship, designed to provide the Associate Director with important skills that they can carry through to their own development.

For 12 months from appointment, the Associate Director will participate in all aspects of the Board work without voting rights.

Associate Director will learn about:

- The fundamental principles of the work and function of the Board.
- The roles and responsibilities of Board members.
- Financial processes.
- Other governance priorities.

Person Specification:

- The opportunity is open to any ALIL shareholder who has an interest in assuming a governance role.
- The person should have an interest in the irrigation sector.
- The purpose of the Associate Director is to develop an individual's governance skills; therefore, the applicants need not have previously served in similar capacities.
- The person should bring knowledge and skills to be able to add to the views of the ALIL Board.

Selection Criteria:

- Willingness to bring their perspective to the deliberations of the ALIL Board.
- Aspirations for leadership in the irrigation and/or broader agriculture sector.
- Breadth of experience in complementary sectors.
- Availability to contribute to ALIL Board meetings.
- Demonstration of career progression.

Selection process:

A selection committee of two ALIL Board members will assess Expressions of Interest and then interview a shortlist of candidates. It is hoped an appointment will be made in December 2024, for an individual to attend ALIL Board meetings during 2025 however, ALIL reserves to the right to accept or decline any Expression of Interest.

Expenses:

Travel associated with training and other reasonable expenses will be covered by ALIL.

Term:

The term would be for one calendar year, starting on Wednesday 29th January 2025. During the term of the role the Associate Director would be offered the opportunity to attend Director training courses at ALIL expense unless this training has already been completed. There may be a requirement to repay training costs if the position is not upheld for the 12 months. The Associate Director would not be eligible to stand for election on the ALIL Board during the term of the Associate Director role but would be eligible at the following AGM.

Applications:

Expressions of Interest should include a summary of your career to date, how your skills, attitude, and experiences would benefit ALIL Board decision-making, why you would like the position, what you would hope to achieve, and how it fits with your future aspirations.

Directors Update

Over this year, the board of Ashburton Lyndhurst Irrigation Ltd (ALIL) has been providing updates in each newsletter, for individual directors to explain their involvement with the scheme & the issues they hold dear. This month, we would like to introduce Steven Bierema.



Having grown up on a farm at sea level behind a dyke, water has always been part of my life. To be able to control the amount of water is essential for a viable farming operation.

In 2017 I was challenged to put my name up for election on the board of ALIL. As a relatively new shareholder and with limited knowledge of the irrigation scheme I took the plunge and was fortunate to be elected.

Freda and I, together with our three young boys, migrated in 2004 from the northern part of the Netherlands to Mid Canterbury. As passionate crop farmers we were able to convert a dryland farm into an irrigated mix cropping farm on Thompsons Track.

Over the years a neighbouring farm came up for sale and along with it, the opportunity to become an ALIL shareholder. After his studies at Lincoln our middle son Pieter-Taco has joined the business and is nowadays in charge of the day-to-day running.

Going back in history, with the development of the RDR and subsequently the border dyke in Mid Canterbury, the fortunes of the region had been set.


Bucket Testing

Bucket tests indicate how your irrigators are performing and are evidence required for the audits. The graph below indicates that while overall bucket test grading has improved, there are still improvements to be made.

As per the policy implemented by ALIL last year, should any shareholder have their environmental audit downgraded because they have not completed bucket testing, then ALIL will carry out the bucket test/s and the shareholder will be charged for the cost.

Don't leave it till the minute before an audit. We have the staff available who will:-

- Provide a hassle-free service and results via the CropX Bucket Test App.
- Test result notification will determine the application rate, depth & distribution uniformity, which will assist with compliant irrigation systems.
- Full Irrigation System Performance Assessment also available by qualified technician.
- Bucket Tests are required for all irrigators and need to be completed **every three years**. The cost for Bucket Tests include:-



Pivots & Lateral:

- Up to 9 spans \$150 per irrigator
- 10 spans or more \$175 per irrigator
- Corner Arm \$25 (additional charge)

Other Irrigators:

- Hard Hose Guns, Rotary & Linear Booms
 \$175 per irrigator
- K-Lines \$5 per pod, minimum \$50
- Irrigation System Performance assessment \$85 per hour

Winter Grazing Reminder

When planning crops for the 2025 winter, please ensure the total area does not exceed the allowed area for your property. If you're not sure what this area is, please check your Property Parameter Report. Any exceedances will require a Farm Activity Variation Application (FAVA) and board approval before undertaking the activity.

Storage

The construction of the storage dam on McKendry's road continues to progress well, however, the contractor completing the earthworks has advised that preparing the material for the lining of the pond has taken longer than anticipated. It is now expected that the pond will be completed by the end of January 2025.
